14th Vienna Economic Forum - Vienna Future Dialogue 2017

For the 14th time, the November issue of the Vienna Economic Forum VEF brought together highranking representatives and visionaries from business, politics and diplomacy from the region, Europe and neighbouring regions at the Novomatic Forum on November 6, 2017 under the motto "Economy Meets Politics".

At the official opening, the CEO of Novomatic AG, host and Vice President of the VEF, Mag. Harald Neumann and the Secretary General of the VEF, former Ambassador Dr. Elena Kirtcheva, together with Dr. Guenther Rabensteiner, President of the VEF, and Dr. Heinz Fischer, President of Austria (2004-2016) and patron of the VEF, welcomed high-ranking participants from 38 countries of the world. In his opening speech, H. E. affirmed Zoran Zaev, Prime Minister of Macedonia, underlined the important role of the VEF in meeting the challenges of the region, in particular with regard to EU integration and the promotion of appropriate instruments to strengthen economic and political cooperation for the benefit of citizens and businesses.

This year's motto of the 14th Vienna Economic Forum - Vienna Future Dialogue 2017 was "Economy meets politics" and underlined the need for cooperation between business and politics. In this context, the dynamics and associated changes in the digitalisation of all areas of life and the role of regional cooperation as part of European integration were also discussed.

In her opening speeches, Dr. Guenther Rabensteiner, President of the VEF, and former Ambassador Dr. Elena Kirtcheva, Secretary General of the VEF, stressed the necessity of this pro-European economic platform in order to enable further establishment and better development of economic regional cooperation from Vienna. Both thanked the partners of VEF for a 14 year success story.

The morning session, moderated by Dr. Ognian Donev, Chairman of the Board of Directors & Executive Director of Sopharma PLC and Vice President of VEF, focused on "We live in a digital time! Visions and investors' response ". At the subsequent Farewell Reception, the concluding thoughts and conclusions were exchanged between all participants and speakers in a festive atmosphere and thus marked the end of another successful Vienna Economic Forum.
